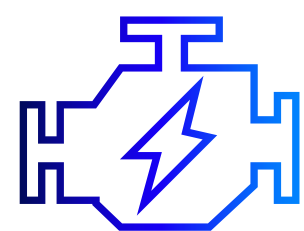

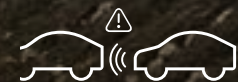
Intelligent Adaptive Cruise Control with Stop & Go and Lane Centering⁶
